Spring Transformation Challenge – Official Rules and Terms

1. Sponsor and Administration

The Spring Transformation Challenge (the “Challenge”) is sponsored and administered by Peak Performance LYP Corp. (“Company,” “Sponsor,” or “Gym”), operating as Peak Performance | Caio Terra Academy Queens. The Company is solely responsible for the organization, administration, and execution of the Challenge.

2. Contest Description

The Challenge is a skill-based promotional contest intended to promote fitness, accountability, and healthy lifestyle improvements. Participants will compete based on measurable performance, specifically the greatest percentage reduction in body weight over the designated contest period.

3. Contest Period

The Challenge will commence on April 2, 2026, with an official initial weigh-in and will conclude on May 23, 2026, with a final weigh-in. All weigh-ins must be conducted in person at the Gym under the supervision of authorized staff.

4. Eligibility

Participation is limited to active members of Peak Performance | Caio Terra Academy Queens who are eighteen (18) years of age or older at the time of entry. All participants must complete required registration documentation, including waivers and acknowledgments, and must complete both the initial and final weigh-ins to remain eligible for prize consideration.

5. Entry; No Purchase Necessary

No purchase is necessary to enter or win the Challenge. Eligible participants may enter either by registering in person at the Gym or by utilizing the alternative method of entry (“AMOE”) by completing the official entry form available at peakfitnessny.com/spring2026challenge-altentry. All entries must be received and accepted prior to the commencement of the Challenge.

6. Determination of Winner

The winner will be determined based on the highest percentage of body weight lost during the Challenge period, calculated as $(\text{Starting Weight} - \text{Final Weight}) \div \text{Starting Weight} \times 100$. All measurements will be taken using Gym equipment and verified by authorized staff, whose determinations shall be final and binding.

7. Weekly Check-In Requirement

Participants are required to check in with Gym staff once per week, each Thursday, throughout the duration of the Challenge. These weekly check-ins will be used to monitor participant progress, update the official leaderboard, and ensure ongoing accountability. Failure to complete required weekly check-ins may, at the sole discretion of the Company, result in exclusion from leaderboard updates and/or disqualification from prize eligibility.

8. Tie-Breaking Procedure

In the event of a tie, each tied participant will be allocated ten (10) entries in a random selection process, with each entry representing one (1) point. Entries will be randomly drawn one at a time by the Company, and the first participant to accumulate three (3) points through this process will be declared the winner. All determinations made by the Company with respect to the tie-breaking procedure shall be final and binding.

9. Prize

The Grand Prize consists of three (3) months of complimentary membership at Peak Performance | Caio Terra Academy Queens. The prize is non-transferable, has no cash value, and may not be redeemed for cash or substituted. The prize must be used by the awarded participant and is subject to the Gym’s standard membership terms and conditions.

10. Health and Safety Acknowledgment

By participating in the Challenge, participants acknowledge that physical training and weight loss activities involve inherent risks, including the risk of injury, illness, or other health-related complications. Participants agree that they are voluntarily participating and assume full responsibility for their health and well-being. Participants further agree not to engage in unsafe or extreme practices, including but not limited to dehydration or extreme dieting, and are encouraged to consult with a qualified medical professional prior to participation.

11. Disqualification

The Company reserves the right, in its sole discretion, to disqualify any participant who fails to comply with these Official Rules, fails to complete required weigh-ins or weekly check-ins, provides false or misleading information, or engages in unsafe, unethical, or unsportsmanlike conduct.

12. Media and Likeness Release

By entering the Challenge, participants grant the Company and its affiliates the irrevocable right and permission to photograph, record, and otherwise capture their image, voice, and likeness, and to use such materials, including participant names and results, for promotional, advertising, marketing, and commercial purposes in any media now known or hereafter developed, without further notice, approval, or compensation, except where prohibited by law.

13. Indemnification

Participants agree to indemnify, defend, and hold harmless Peak Performance LYP Corp., its owners, officers, employees, agents, and affiliates from and against any and all claims, demands, liabilities, damages, losses, costs, and expenses, including reasonable attorneys' fees, arising out of or related to participation in the Challenge, any violation of these Official Rules, or any injury, loss, or damage caused by or attributable to the participant.

14. Modification, Suspension, or Cancellation

The Company reserves the right, in its sole discretion, to modify, suspend, or cancel the Challenge at any time due to circumstances beyond its control or as otherwise deemed necessary for operational, legal, or safety reasons.

15. Limitation of Liability

To the fullest extent permitted by law, participants agree to release and hold harmless the Company and its affiliates from any and all liability arising out of or in connection with participation in the Challenge or acceptance, use, or misuse of any prize.

16. Acceptance of Terms

By entering the Challenge, participants acknowledge that they have read, understood, and agree to be bound by these Official Rules and all decisions of the Company, which shall be final and binding in all respects.
